Did you sign your form? Both pages must be signed! Reservations are not valid without at least one participant signature from your party! Use of credit cards requires an additional signature by the actual card holder!

Terms, Conditions, and Responsibilities:

Reservation Form: Before sending your reservation form and payment, it is always wise to check our online reservations system to instantly determine if space is available, or call/email us. A fully completed reservation form and payment are required to confirm a reservation. Please be as legible as possible!

Deposit: We must receive a payment to confirm your space. If your trip begins less than 30 days from now, full payment is required with your reservation form. A deposit of 50% must be paid if your reservation is made more than 30 days in advance. Deposit amounts are per person. The full balance is due 30 days before the first day of your trip.

Method of Payment: We encourage you to pay with personal check, money order or cashier's check payable to Sea Quest Expeditions. Checks drawn on foreign bank accounts must be designated in US funds. Visa, MasterCard and Discover are the only credit cards accepted. *Credit card users must sign BOTH pages of this document.*

What Happens Next: Upon receiving your completed reservation form and payment, we will send you a confirmation by email. Included in the email are important attachments for comprehensive pre-trip information and packing. A suggested reading list is provided along with medical and liability release forms. For those without an email address or web access, we can fax or post mail to provide you with these materials.

Age Limitations: San Juan Island day-trips allow children as young as five years to participate. Camping trips in the San Juans require children to be at least eight years of age, except in the case of custom trips. To paddle in a tandem (two-person) kayak a child must be physically fit and weigh at least 100 pounds. Smaller children will need to paddle in triple-cockpit boats with two other full-size paddlers, including at least one parent or much older sibling. We have a limited number of triple-cockpit kayaks so be sure to request about availability and reserve in advance. Exceptions can sometimes be made by arranging for a custom tour. Parties that desire to include young children are encouraged to schedule custom trips or to participate in expeditions designed especially with families in mind. Call us to discuss this and we can help match your family or group with another of similar interests and ages!

Release of Liability: Each participant is required to complete, sign and return to us a "Participant Agreement and Acknowledgements; Waiver, Release and Indemnity Form" (Liability Release) before being allowed to participate in any trip. This document releases *Sea Quest Expeditions* and *Zoetic Research* from liability in the case of accident or injury for any reason. This document includes a place for minors to sign, but their signatures must be accompanied by both parents or legal guardians on the form. You will also need to complete our online questionnaire regarding your medical condition if you are participating on a multi-day tour. If web access is unavailable you may complete a printed version.

Travel: We are pleased to provide detailed information on our website Travel Info pages to help you get to trip departure points. Although we may assist you with certain arrangements, all travel to and from trip departure points is the sole responsibility of the participant. We are not responsible for expenses arising from the delay, extension, or cancellation of a trip due to weather, airline performance, or other causes beyond our control.

To get from the designated trip departure point to the actual boat launching location, it may be necessary for us to employ transportation services such as taxi, float plane, or boat charter. *Sea Quest Expeditions* and *Zoetic Research* acts only as agents in regard to that particular part of a trip, and can assume no liability for any actions or defaults of any individual or organization with whom such arrangements have been made.

Fortunately for everyone, cancellations of a scheduled trip are an *extremely* rare occurrence. Nevertheless, we must reserve the right to cancel any trip prior to departure for any reason whatsoever. The refund of all payments received shall release *Sea Quest Expeditions* and *Zoetic Research* from any further liability, including expenses incurred by participants in preparation and travel for the trip.

Medical Insurance: All trips are led by guides with first-aid qualifications and communication equipment. However, *Sea Quest Expeditions* and *Zoetic Research* assumes no responsibility regarding provision of medical care or evacuation. We advise you to examine your present insurance policy to make certain you possess adequate medical and personal injury coverage for travel in remote areas. Most travel insurance policies will cover this.

Cancellation Policy: Cancellations must be received in *writing* to be official, and the refund rates are based on the date of receipt. Please also alert us unofficially by phone or email if you are canceling all or part of your reservation.

Refund Policy: This refund policy must be adhered to as a sizable portion of trip expenses are committed well in advance of scheduled departures. An administration fee is applied to all cancellations. Administration fee for all tours is \$50. More than 30 days prior to departure: full refund minus the administration fee. Sixteen to 30 days prior to departure refund equal to 50% of the trip fee remaining after the administration fee is deducted. Zero to 15 days prior to departure: full amount retained.
